RESOLVED: THAT Northwood Parish Council object to this application on the following grounds:



- it is outside the settlement boundary
- the location is unsustainable; there is no footway, the road is narrow and very dangerous for pedestrians
- concerns about access creating more traffic on an already very dangerous road. Northwood Parish Council have been campaigning to improve safety on this road for the past 3 years which is frequently used as diversionary route when the main Cowes to Newport Road is closed.

Should the application be approved any S106 agreement should contain at the applicant's expenses all the measures identified by Northwood Parish Council in an open letter sent to the Leader of the IWC on 4th December 2024 re. traffic safety issues on Pallance Road including reducing the speed limit, improving safety signage, and installing speed indicators.
