

## MINUTES OF THE NORTHWOOD PARISH COUNCIL MEETING held at 6.30pm on Tuesday 7th October 2025 at Northwood Primary School, Wyatts Lane, Northwood.

The Chair welcomed the members of the public to the meeting who wished to discuss two issues - flooding on Wyatt's Lane (agenda item 101/25-26) which would be brought forward to the start of the meeting (minute no. 93/25-26), and speeding on Oxford Street where concern was raised about the 20 MPH restriction being ignored especially dangerous when cars are parked on both sides of the road in the vicinity of the school at drop off and pick up times. The Clerk would ask the police to monitor speeding on Oxford Street and Wyatts Lane. She would also request an update from Northwood Primary School on the progress with the Junior Travel Ambassador (JTA) scheme agreed on in June and add to the agenda for November's Full Council meeting for further review.

	Cllr Nicholson provided an update on progress made to resolve issues for residents in		
	Wyatts Lane whose properties are regularly flooded out in heavy rain. Since the last		
	meeting Southern Water have carried out a thorough investigation in locations that		
	utilise a combined foul and surface water drainage system, and Island Roads have		
	checked and cleared a number of their drains in Uplands Road near the junction with		
	Wyatts Lane, and on Wyatts Lane, but with such significant rainfall over recent years,		
	the gullies have been overwhelmed and unable to drain the amount of water quickly		
	enough. Residents explained how resurfacing works have added to the problem by raising the surface of the road resulting in less clearance from the kerb, and that		
	additional debris collects and transports into the drainage system adding to the		
	problem. Cllr Nicholson reported that Island Roads are looking into a long-term drainage		
	scheme which householders might be willing to contribute to, and the question was		
	asked as to whether there were grants available to help with this, such as the Property		
	Flood Resilience (PFR) grant scheme Cllr Gallop identified which can provide up to		
	£5000 for eligible households to install PFR measures.

It was questioned how access path could have been part of a S106 contribution if it was already in the original plans and that it left no further opportunity to negotiate the Parish Council's S106 priorities? Cllrs Flux and Martin requested it be placed on record their disagreement and disappointment with the whole process.

## 100/25-26 Review of the Parish Council's Assets

Cllr Nicholson had circulated his review of assets highlighting some of the planters that needed repair (which Tony Hewitt had also raised with the Clerk and would price up in the Spring), and that the swings at Venner Avenue needed painting. The Clerk had asked the IWC about the swings and they advised that they were looking at purchasing a compressor air gun to do this and would be in contact in due course. Cllr Nicholson queried whether Councillors would want to move the Gateway Sign on Place Road nearer to the corner of Three Gates Road to better reflect the parish boundary, and, if members would like to see seating on the grass corner at Three Gates Road. It was suggested that BAE Systems might want to sponsor seating in this location.

RESOLVED: THAT the Clerk ask the IWC if they had any objection to seating on this corner before progressing with BAE Systems. To be reviewed at the next meeting.

## 102/25-26 Horsebridge Hill Development

To consider issues ahead of works by Southern Water at Horsebridge Hill in the new year. It had been stated originally that Newport Road would need to be closed in both directions, but it was reported by Richard Quigley MP in May 2025 that due to the progress already made, the planned works for 2026 would be carried out quicker and with two-way traffic lights in place, which would be welcomed. There continued to be issues with the lights going red and staying red, and if it is a software issue as experienced elsewhere on the Island, Cllr Fuller warned it would need mainland services to fix.

RESOLVED: THAT the Clerk write to Michelle Love, IWC Service Director for Highways and Community Protection, to ask about the status of road closures ahead of the planned works and request an assessment of the wider impact for pedestrians on Pallance Road and Oxford Street when there will be an increase in traffic and earlier dark evenings.



It was suggested that it would be in everyone's interest to have a joint meeting with Ward Councillors and Town and Parish Council representatives from Northwood, Gurnard and Cowes all of whom had a stake in resolving issues ahead of the works, and that this could be held at Building 41.

RESOLVED: THAT CIIr Fuller contact Michelle Love to organise an in-person joint meeting for all parishes and interested parties to discuss issues ahead of the works.

104/25-26 Island Transport Plan Consultation 2025-2040

To review and agree any response to the Island Transport Plan Consultation 2025-2040. Cllr Nicholson commented that it was a good plan, but it didn't address the disruption on the road caused by utility companies, the need for more robust enforcement powers for the IWC and Police to deal with abandoned cars, nor did it address a lack of parking facilities. Cllr Fuller advised about the government's 'Lane Rental' scheme used elsewhere which was designed to encourage behavioural change for those carrying out works on the highway by applying a charge for the time companies occupy certain roads on the network during busy times, and that there might be scope for it to be used on the Island. Members proposed it was also an opportunity to improve disabled access and weatherproof bus stops which have been raised as concerns locally and that a forward-thinking approach was required to support those with mobility issues which Cllr Fuller reported he was reviewing currently through the Local Access Forum.

RESOLVED: That the following issues be raised in response to the Island Transport Plan Consultation 2025-2040:

- The need for a forward-thinking approach to mobility issues
- The need to weatherproof bus stops
- Adoption of the Lane Rental scheme
- Recognition of ferry services being integral to the Island's economy and quality of life.

- c. **Councillor reports** Cllr Martin provided an update on behalf of the Projects Group. Warm Spaces was going well with the new format. They were collecting donations for the Radio Solent Soapbox Appeal and asked if this could be advertised through the Northwood News. He reported that he had attended a 'beyond the precept' training session which he'd hoped would be useful, but it was aimed at larger Councils with big portfolios and not very relevant for parishes the size of Northwood. He would be



attending the Village Hall AGM at the end of October and his next audit meeting with the IWC was scheduled for 17<sup>th</sup> October. Cllr Fuller had circulated a written report and highlighted that McDonalds were hosting an in-person exhibition regarding their proposals for a new Drive Thru restaurant on Three Gates Road in Cowes from 3-7pm at Cowes Baptist Church on Thursday 16th October 2025.
